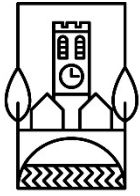

## STRATHALBYN HARNESS RACING TRACK

We are pleased to open bookings for the 2018 Treasure Market to be held at the Strathalbyn Harness Racing Club Milnes Road.

There are no sheltered areas trackside so the size of the site is to allow you to trade from your vehicle or to erect an awning or small marquee. Stalls can be set up on either side of the track facing inwards, leaving a walkway in the centre. Park your vehicle behind your stall.

There are a limited number of sites available inside the Stables, these inside sites will be 4m lineal. Power is available in the stables with 1 power point for every two sites, so they will require sharing. Stalls must be set up facing each other to create a walkway down the centre of the building. There will be plenty of space behind your site to store goods. You will be able to drive vehicle into the Stables to set up. A special parking area nearby has been arranged, please move vehicles from the Stables to this area as soon as you have unloaded.

Trading times are from 8.00am to 4.00pm.

No bookings will be taken for the Treasure Market after the cutoff date (31 July 2018) so please book early. Sign the application form where indicated and return with your site fee and your insurance Certificate of Currency. If you wish to arrange insurance through SLTA include the \$30 in your total fee payable. Please note the conditions of insurance.

Conditions of the Treasure Market are on the reverse side.

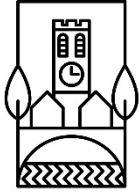

# CONDITIONS

STRATHALBYN TREASURE MARKET  
SUNDAY 19 AUGUST 2018  
STRATHALBYN HARNESS RACING TRACK

1. Trackside site size is 5m wide by 4m deep, each site costs \$45.00 and is charged per site only. If the site is larger you will be charged for an extra site on the day.
2. The gate will be opened at 5.30am. Please do not block the gates (they will be locked).
3. Sites must be set up by 8.00am in time for entry of the public.
4. Ensure your marquee is secured to the ground and does not cause a hazard.
5. Stalls must stay open until closing time of 4.00pm. No vehicles are to be moved before 4pm.
6. Sites must be left in a clean condition with rubbish placed in the skip next to Stables.
7. Stalls must leave centre of track free for pedestrian traffic. Cars must be parked behind your site. Only one vehicle per site is permitted.
8. Treasure Market stallholders are unable to camp onsite the night prior to event.
9. There are no trestles available for hire.
10. An ATM will be located onsite.
11. The site is a smoke free venue.
12. No firearms, weapons, medicines, pornography or any other material deemed objectionable will be displayed or offered for sale.
13. No Livestock may be offered for sale
14. No dangerous or offensive materials are allowed.
15. Selling of lottery tickets is not permitted.
16. No loudspeakers or any other equipment for amplifying sound shall be used at any time.
17. Stall holders provide authority to SLTA to use photos on our website and social media.
18. If Insurance Cover is provided by SLTA to stallholders, it does not cover ANY second-hand 240v appliances or tools, knives of any sort, children's toys (board games ok), inflatable objects or children's clothing.
19. Market Stall-holders must show respect to the local community by keeping the noise down before 8.00am.
20. The signed application form and full payment is required by 31 July 2018

Final details regarding entry, facilities etc. will be sent to you in early August .
